All Permittees shall abide by the following regulations:

1. Sales Outside the Festival Area - All participants within the permitted festival area must have a permit from the festival sponsor. All other outdoor sales within the Darien city limits must secure a license from the city.
2. Gas Powered Generators - Gas powered generators are prohibited in the central business district during festivals. Permits for emergency generators must be secured from the City of Darien
3. One Permit per Period - PARADES - Only one parade permit may be issued for any festival period. The festival promoter/sponsor must secure and guarantee any parade permit.
4. PARKS - Public parks will be under the control of the festival promoter/sponsor. Liability insurance secured for the festival must include public parks. Public parks must be used for free activities. Promoter must state intended use of Public Park on application.
5. Sales from Booths - All outdoor sales during festivals must meet licensing requirements and must be made from booths or tables. Moving street vendors are prohibited.
6. Clean Up - The festival promoter/sponsor is responsible for clean up. Any extraordinary clean up required will be charged to the festival promoter sponsor. Failure to clean up may result in denial of the future festival permits and. Any city service which requires overtime will be an expense of the sponsor.
7. Carnivals - All carnivals within the city limits during festivals hours must be approved by the city.
8. Horses - Horses, mules, donkeys, and bovine animals must be diapered during parades and parade staging areas.
9. Porte Potties - Porta Potties may be required during festivals. Porta Potties will be the responsibility of the festival promoter/sponsor.
10. Fencing of City Property - It shall be unlawful to fence or obstruct city property unless permission is given as a special condition as set forth by the City Council
11. Charging of Admission - It shall be unlawful to charge for admission on city property unless special permission is given by the City Council.
12. Obstruction of Existing Businesses - Please provide a list of as many signatures as possible of businesses concurring that they are in agreement with their access being obstructed as a result of the event or closing of streets.
13. Inspections - Sponsor shall provide immediate and unrestricted access to police, fire, code enforcement or other city officials for the purpose of inspecting facilities, activities and areas involved in the special event.

14. Emergency Access – It shall be unlawful to block a fire hydrant in such a manner that it restricts immediate access to emergency vehicles and first responders in the event of a fire, medical incident or emergency.
15. Summary Reports – Within 7 days of the conclusion of the permitted event. The sponsor shall provide a written report to the city manager summarizing the following: estimated number of attendees, incidents which occurred, projected revenue generated and recommendations for future events.
16. Parade Safety Rules – Attached is a copy of parade safety rules that should be implemented by the sponsor.
