  - 1. Q The plans dated 05-23-2023 show that Broad Street Parking Lot is to be paved with asphalt, but the Proposal Sheet says concrete, which one is correct?

**A** - *The correct pavement is concrete. If discrepancies occur, please go by the Proposal Sheet unless otherwise specified.* 

- 2. The parking lot is proposed to include a second phase in the near future which will consist of a second parking aisle along the south side of the sidewalk. Wheel stops shall be placed at the future entrance/exit drives along with the EV parking spaces as shown on the revised plans dated 2023-06-20.
- 3. Signage will include post and installation and shall match Historic District Signage. Specific quantity and sign type are as follows:

1–HC Van Accessible Parking

- 2– EV Parking
- 4. Georgia Power will relocate the guy wire.
