**SUPPLEMENTAL MEMORANDUM IN SUPPORT OF
APPLICATION FOR ATTORNEY’S FEES, REIMBURSEMENT OF EXPENSES AND
SERVICE AWARD TO CLASS REPRESENTATIVE**

Lead counsel, James L. Roberts, IV of Roberts Tate, LLC represents Plaintiffs Troy and Taryn Nixon (“Named Plaintiffs”), individually and on behalf of all persons similarly situated, respectfully submits this Supplemental Memorandum of Law in Support of Application for Attorney’s Fees, Reimbursement of Expenses and Service Award to Class Representative (the “Application” or the “Motion”) representing to the Court as follows:

A. Notice to the Class Members

On October 17, 2023 the Court signed the First Amended Preliminary Order granting the Parties’ Joint Motion for Preliminary Approval of Class Action Settlement (the “First Amended Preliminary Approval Order”). See Affidavit of James L. Roberts, IV (“Roberts Aff.”), attached hereto as Exhibit (“Ex.”) “A”, ¶3. In the First Amended Preliminary Approval Order the Court scheduled a final approval hearing (the “Final Approval Hearing”) for February 20, 2024 at 9:00 a.m. Id. at ¶4. The Preliminary Approval Order indicated that at the Final Approval Hearing the Court would determine, among other things, Class Counsel’s request for an award of attorney’s fees, expenses and service award. Id. The Court directed that notice of the [Proposed] Consent

Judgment on Aggregate Refund and Order (the “[Proposed] Consent Judgment”) and the Final Approval Hearing be provided to the Class. Id. at ¶5.

The Court directed that notice be mailed to the Class Members (the “Full Notice”), a notice be published in The Darien News (the “Publication Notice”) and the Defendant City of Darien, Georgia (the “City”) was directed to add a webpage to its website (the “Webpage”) providing information about the Lawsuit and the proposed Settlement (collectively the “Notice Program”). Id. The form and content of the Full Notice and the Publication Notice were approved by the Court in its First Amended Preliminary Approval Order. Id.

The Class Members were advised through the Notice Program that Class Counsel would seek approval for an award of attorney’s fees and expenses. Id. at ¶6. The Full Notice and the Publication Notice advised the Class Members that at the Final Approval Hearing the Court would determine, among other things, Class Counsel’s request for an award of attorney’s fees and expenses. Id. at ¶7.

In the First Amended Preliminary Approval Order, the Court ordered that Class Members objecting to the Class Counsel’s request for an award of attorney’s fees, expenses and service award follow specific procedures to register such objections in order for the objection to be considered by the Court. Class Members were advised of these objection procedures in the Full Notice. Id. at ¶8. The Full Notice advised Class Members that the same day the Application for Attorney’s Fees, Reimbursement of Expenses and Service Award was filed with the Court it would be posted on the Webpage on the City’s website for Class Members to review and download. Id. at ¶9. Through the Notice Program the Class Members were advised that for an objection to be considered by the Court it had to be postmarked on or before January 15, 2024. Id. at ¶10.

B. Execution of the Notice Program

Each facet of the Notice Program was timely and properly accomplished. Id. at ¶11. The Full Notice was mailed to Class Members identified in Exhibit A to the Affidavit of Printing and Mailing to their last known addresses as appearing on the records maintained by the County on December 6, 2023. Id. at ¶12. See also Affidavit of Printing and Mailing (“Aff. of Printing and Mailing”) attached hereto as Exhibit “B”. Four hundred forty-three (443) Full Notices were mailed. See Ex. A, Roberts Aff. ¶12; Ex. B, Aff. of Printing and Mailing. The Publication Notice was placed in The Darien News on November 9, 2023, November 16, 2023, November 23, 2023 and November 30, 2023. See Publisher’s Affidavit attached hereto as Exhibit “C”.

The Webpage was added to the City’s website providing information about the Lawsuit. See <https://cityofdarienga.com/category/news/>. The Website contains the First Amended Preliminary Approval Order, the [Proposed] Consent Judgment, the Full Notice, and other related documents and information concerning the Lawsuit. The Webpage on the City’s website also contains the date of the Final Approval Hearing. See Ex. A, Roberts Aff. ¶13.

The Application for Attorney’s Fees, Reimbursement of Expenses and Service Award was filed with the Court on December 22, 2023. Thereafter the Application for Attorney’s Fees, Reimbursement of Expenses and Service Award was posted on the Webpage on the City’s website. Id. at ¶16.

C. Class Member Reaction to the Request for Fees, Expenses and Service Award

The period for filing timely objections ended on January 15, 2023. There were no objections filed within the Court ordered objection period specifically objecting to the request for an award of attorney fees, expenses and service award or the proposed settlement. There have been no other objections filed to date. Id. at ¶17. Therefore, the reaction of the Class Members to

Class Counsel's request for an award of attorney's fees, expenses and service award has been positive. Id. at ¶17.

CONCLUSION

For the reasons set forth herein and in Application for Attorney's Fees, Reimbursement of Expenses and Service Award to Class Representatives filed on December 22, 2023, Class Counsel requests that the Court grant their Application for Attorney's Fees, Reimbursement of Expenses and Service Award to Class Representative.

PERSONALLY APPEARED before me, an officer duly authorized by law to administer oaths, JAMES L. ROBERTS, IV, who after first being duly sworn states:

1.

My name is JAMES L. ROBERTS, IV, and I am competent in all respects to testify regarding the matters set forth herein. I have personal knowledge of the facts stated herein and know them to be true. This Affidavit is given voluntarily.

2.

This Affidavit is given in support of the Supplemental Memorandum in Support of Application for Attorney’s Fees, Reimbursement of Expenses and Service Award to Class Representative in the above referenced class action (the “Lawsuit”).

3.

On October 17, 2023 the Court signed the First Amended Preliminary Order granting the Parties' Joint Motion for Preliminary Approval of Class Action Settlement (the "First Amended Preliminary Approval Order").

4.

The Court scheduled a final approval hearing (the "Final Approval Hearing") for February 20, 2024 at 9:00 a.m. at the McIntosh County Courthouse. The First Amended Preliminary Approval Order indicated that at the Final Approval Hearing the Court would determine, among other things, Class Counsel's request for an award of attorney's fees, expenses and service award.

5.

The City shall cause a webpage be added to its website (the "Webpage") where Class Members may access the First Amended Preliminary Approval Order, the [Proposed] Consent Judgment, the Full Notice, other related documents and information concerning this Lawsuit and the date that the Final Approval Hearing will occur.

C. The Parties shall cause a notice to be placed in The Darien News (the “Publication Notice”). The Court approved the form and content of the Publication Notice.

6.

The Class Members were advised through the Notice Program that Class Counsel would seek approval for an award of attorney’s fees and expenses.

7.

The Full Notice and the Publication Notice advised the Class Members that at the Final Approval Hearing the Court would determine, among other things, Class Counsel’s request for an award of attorney’s fees and expenses.

8.

Thereafter the Application for Attorney's Fees, Reimbursement of Expenses and Service Award to Class Representative was posted on the Webpage on the City's website.

The period for filing timely objections ended on January 15, 2023. There were no objections filed within the Court ordered objection period specifically objecting to the request for

an award of attorney fees, expenses and service award or objecting to the proposed settlement.

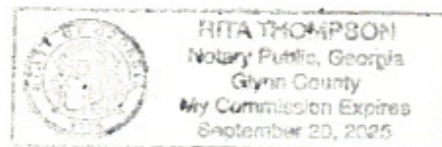

You are a member of the Class if you are or were a City of Darien property owner receiving the Exemption in the calculation of your tax bills in 2016, 2017, 2018, 2019, 2020, 2021 or 2022 and for whom the City of Darien used the year in which the Exemption was first granted as the base year rather than the immediately preceding year in calculating the exemption amount under H.B. 1197 for property tax bills in 2016, 2017, 2018, 2019, 2020, 2021 or 2022 and for whom the value frozen in the year in which the Exemption was first granted is greater than the value in the immediately preceding year.

If no objections are filed, the Court may elect to hold the hearing telephonically or virtually.

If you are a member of the Class as defined above, your rights may be affected by the proposed Settlement as set forth in the [Proposed] Consent Judgment.

You do not have the right to exclude yourself from the Settlement in this Lawsuit, but you do have the right to object in writing. Any objection by a Class Member must be postmarked on or before January 15, 2024 and must comply with the requirements stated in the [Proposed] Consent Judgment. After the Settlement has been approved by the Court, if you still own the property for which a refund is determined to be owed, you will not be required to do anything to receive your refund.
